14 Describe the organizational action and, if applicable, the date of the action or the date against which shareholders' ownership is measured for the action ▶ ON APRIL 15, 2016, LIBERTY MEDIA CORPORATION ("LMC") REPAPITALIZED ITS EXISTING COMMON STOCK. IN THE RECAPITALIZATION, EACH ISSUED AND OUTSTANDING SHARE OF LMC'S SERIES K COMMON STOCK (LMCK) WAS RECLASSIFIED AND EXCHANGED FOR: 1 SHARE OF SERIES K LIBERTY SIRIUSXM COMMON STOCK (LSXMK), 0.25 OF A SHARE OF SERIES K LIBERTY MEDIA COMMON STOCK (LMCK), AND 0.1 OF A SHARE OF SERIES K LIBERTY BRAVES COMMON STOCK (BATRK). CASH WAS PAID IN LIEU OF FRACTIONAL SHARES.

15 Describe the quantitative effect of the organizational action on the basis of the security in the hands of a U.S. taxpayer as an adjustment per share or as a percentage of old basis ▶ THE TAX BASIS OF EACH SHARE OF LMCK HELD IMMEDIATELY PRIOR TO THE RECAPITALIZATION SHOULD BE ALOCATED: 79.392% TO THE 1 LSXMK SHARE, 14.747% TO THE 0.25 FRACTION OF THE LMCK SHARE, AND 5.861% TO THE 0.1 FRACTION OF THE BATRK SHARE RECEIVED IN EXCHANGE FOR SUCH LMCK SHARE HELD IMMEDIATELY PRIOR TO THE RECAPITALIZATION.

17 List the applicable Internal Revenue Code section(s) and subsection(s) upon which the tax treatment is based ► THE RECAPITALIZATION IS INTENDED TO QUALIFY AS A TAX-FREE REORGANIZATION UNDER IRC SECTION 368(a)(1)(E), AND ACCORDINGLY, LMC SHAREHOLDERS WILL NOT RECOGNIZE INCOME, GAIN, OR LOSS WITH RESPECT TO THE RECAPITALIZATION, EXCEPT WITH RESPECT TO CASH RECEIVED IN LIEU OF FRACTIONAL SHARES.
